## **About CAAB**

CAAB is one of several City Commission appointed Boards created to improve the quality of life for those who live and work in Wilton Manors. This seven-member volunteer Board is charged with offering support for and producing activities and efforts that positively impact the community.

## **The Community Spirit Awards**

The Skip Stadnik Community Spirit Awards are intended to engage local residents and business owners to acknowledge those who deserve recognition for their spirit of giving. A Volunteer of the Year exhibits efforts for beautification of the city, supports issues of community concern, disseminates education, and/or publicizes the benefits of doing business in the city. The nominee cannot receive any monetary or personal benefits from their involvement and their volunteer service must be unrelated to their job description. Volunteer Business of the Year will be awarded to an outstanding business, business association or not-for-profit organization located in Wilton Manors or one that provides direct service to area residents. The entity will be recognized for improving the quality of life for residents and promoting the welfare of the community. The business owner is not required to reside in Wilton Manors.

**Advocacy and Being a Role Model:** How they improved the quality of life in Wilton Manors; supported issues of concern; encouraged city beautification; demonstrated creative influence through the support of artistic endeavors; publicized the benefits of doing business in Wilton Manors; served as a mentor in the community; helped others reach their goals; demonstrated commitment of the highest ethical standards.

**Leadership and Philanthropy:** Demonstrated spiritual influence; inspired others; had a positive impact on the direction/success of City projects, programs, or individuals; sponsored programs/events; provided goods, services, or financial support for a program/event.

The selected honorees will be chosen in the CAAB meeting of April 8, 2026 and presented in the annual Volunteer Appreciation Event.
